**Police Report, Chief Terry Sivert**

Chief Sivert reports 4086 miles patrolled, no maintenance on vehicles. Nine traffic citations written. 99 calls answered, 7 motorists assisted with lockouts, 7 arrest (2 Capias, 1 Distribute schedule I or II narcotics, 2 Assault and Battery, 1 Drunk in Public, 1 Destruction of Property). Fines Assessed/Collected: \$616.00 JPD assisted County on various calls. Helped citizens in obtaining warrants and orders from magistrate. Assisted fire and rescue with calls. Provided routine escorts IGA, Shubert's and Lee Food Mart. Assisted Sheriff's Office with funeral escorts in town.

**Town Superintendent Report, Jimmy Cluesman**

Mr. Cluesman reports 6 warnings, 4 disconnect, 3 reconnects. Several small leaks were repaired. The interconnection with PSA at the water plant is complete, no contract or price has been set. The septic system at the water plant had to be pumped.

**Water Plant Supervisor Report, Brian Bush**

Mr. Bush reports 9.5 million gallons water produced, 4.4 million sold, 2.6 million gallons sold to Woodway Water Authority with a 50% total loss of water and a average pump time of 17 hours.

**Advertising for Gray Chevrolet Impala**

The motion was rescinded to sale the car for junk/scrap metal. Tony Collier made the motion to take sealed bids for the Gray Chevrolet Impala; seconded by Tommy Livesay. All in favor, motion carries.
