Phase I Water System Improvement

This project on Park Street is almost complete with a 12 inch water line being installed and 6 leak detection meters.

Planning Grant Leak Detection

Bench testing was completed on several water meters, 11 of those meters did not meet standards. Seventy-six percent were low, 96% mid, and 95% high.

# Phase II Water System Improvement

This grant will replace old galvanized lines on the south side of town.

Brian Huff made the motion to approve the financial reports; seconded by Jerry Harris. All in favor, motion carries.

Tommy Livesay made the motion to approve the bills to be paid; seconded by Rebecca Hines. All in favor, motion carries.

### Police Report, Chief Terry Sivert

Chief Sivert reports 2583 miles patrolled, no maintenance on Dodge #1 and 2 and Equinox, Dodge #3 had to have new radiator and fan.. Eleven traffic citations written. 111 calls answered, 12 motorists assisted with lockouts, 14 arrest (2 Shoplifitng, 1 Trespassing, 1 Possess Schedule I, 2 Possess Schedule IV, 1 Drunk in Public, 7 Assault and Battery). Fines Assessed/Collected: \$902.00, Collected \$123.50. JPD assisted County on various calls. Helped citizens in obtaining warrants and orders from magistrate. Assisted fire and rescue with calls. Provided routine escorts IGA, Shubert's and Lee Food Mart. Assisted Sheriff's Office with funeral escorts in town.

Sheriff Parsons has asked Chief Sivert and Sgt. Mullins to be on a Response Team that is being formed.

## Town Superintendent Report, Jimmy Cluesman

Mr. Cluesman reports 7 warnings, 7 disconnect, 6 reconnects. Several small leaks were repaired, 8 Miss Utility tickets responded to, 32 work orders completed, 4 days of garbage pickup and fixed potholes on Russell, Richmond, Dale and Couk Street.

#### Water Plant Supervisor Report, Brian Bush

Mr. Bush reports 9.7 million gallons water produced, 5.9 million sold, 3.5 million gallons sold to Woodway Water Authority with a 40% total loss of water and a average pump time of 17 hours. Virginia Department of Health has not approved purchasing water from PSA except for in an emergency situation.

## **Unfinished Business:**

Gibson Building on Park St.

Bobby Slusher made the motion to provide Police Chief Terry Sivert with a take home car in light of his appointment to the Special Response Team. This would benefit him in being able to respond quicker if called by providing him with lights and sirens .Magen Harris seconded this motion. Roll call vote was as follows:
