# **Petitions and Communications-Visitors**

Angie Collingsworth petitioned the council requesting the funds from the July 4<sup>th</sup> Road Race be used for purchasing cheerleading uniforms for the Lee Middle School. The last meeting a motion was made to continue dispersing as a scholarship to a Lee High and Thomas Walker student. After council discussion the motion from last meeting was rescinded by Brian Huff, second Bobby Slusher, and all in favor. A new motion was made to allow the funds to be used for purchasing cheerleading uniforms by Brian Huff, second by Bobby Slusher, all in favor.

Bill Munsey also petitioned the council regarding the recent vote of allowing Chief Terry Sivert to take a town vehicle to his residence in Gate City, VA. Mr. Munsey asked the four that voted yes to the reason for allowing him to do so. Councilman Bobby Slusher stated that this decision was made so he may respond quicker if needed to come from home and also that he is a member of a Special Response Team that requires quick response.

## Police Report, Chief Terry Sivert

Chief Sivert reports 4299 miles patrolled, no maintenance on Dodge #1 and Dodge #2, Dodge #3 has a starter and siren issue and Equinox down due to radiator hose accessory. Fifteen traffic citations written. 113 calls answered, 10 motorists assisted with lockouts, 20 arrest (2 DUID, 1 Felony Hit and Run, 1 Refusal, 1 Drunk in Pblic, 1 Felony Child Neglect, 1 Curse and Abuse, 1 Driving Suspended, 3 Capias, 1 Fugitive from Justice, 1 Grand Larceny, 1 Shoplifting, 6 Probation Violation). Fines Assessed/Collected: \$324.00. Two temporay detention orders (Lebanon and Marion) JPD assisted County on various calls. Helped citizens in obtaining warrants and orders from magistrate. Assisted fire and rescue with calls. Provided routine escorts IGA, Shubert's and Lee Food Mart. Assisted Sheriff's Office with funeral escorts in town.

# **Town Superintendent Report, Jimmy Cluesman**

Mr. Cluesman reports 8 warnings, 7 disconnect, 6 reconnects. Several small leaks were repaired, no major water or sewer repairs, 7 Miss Utility tickets answered, 800 meters read, completed work orders, mowed and hauled garbage weekly. The 12 inch line at Powell Valley Electric is ready just waiting for VDH to approve to turn it on. Nicoletta Mcknight's meter returned with 98.8 % accuracy.

## Water Plant Supervisor Report, Brian Bush

Mr. Bush reports 11 million gallons water produced, 5.6 million sold, 3.4 million gallons sold to Woodway Water Authority with a 49% total loss of water and a average pump time of 18.5 hours.

# Dr. Brian Austin, Lee County School Board Superintendent

Dr. Austin petitioned the council on forming a partnership between the Lee County School Board and Town of Jonesville to place a School Resource Officer at Jonesville Middle School. Lee County School Board is willing to help fund this position along with financial assistance from the town. The School Board will meet Thursday and Dr Austin will then provide the amount of assistance. The council will discuss further in Executive Session.

## George Cridlin, Town Charter

Town Attorney George Cridlin addressed the council regarding changing the Town Charter form 2 year terms to 4 year terms for mayor and council and reducing number of council members from 7 to 5. According to his research either a public hearing or it must be put on the ballot at the next election in May 2018.

# **Appointment of Town Attorney**

#### **Police Cars**

Chief Terry Sivert addressed the council concerning the Dodge #3 and the Equinox needing repaired. He expects the repairs to be expensive with the maintenance budget for cars almost depleted due to extensive repairs earlier. He obtained quotes for purchasing a new vehicle and trading these two in. A new Jeep Compass could be purchased for \$15,000. No action was taken at this time.

Jerry Harris made the motion to enter into Executive Session for Personnel under VA Code 2.2.3711A; seconded by Brian Huff. All in favor, motion carries.
